Note:-

i) Paper-I:- Paper-I will contain 2 (two) sections i.e Section-I and Section-II. Section-I will contain Comprehension and English Grammar and questions under this section are of Conventional type. Section-II will contain Computer (Basic Knowledge), Mathematics (Basic) and Science (Basic) and questions under this section are of objective type. Candidates will have to answer both the Sections in the Answer sheet in English only.

ii) Paper-II:-

Part-I: There will be 50(fifty) MCQ type questions each carrying 1 (one) mark which are to be answered in the OMR sheet by black point pen only.

Penalty for wrong answers (Part-I of Paper-II):-

- a) There will be four alternatives for the answer to every question. For each question for which a wrong answer has been given by the candidate, one-fourth of the marks assigned to that question will be deducted as penalty.
- b) If a candidate gives more than one answer, it will be treated as a Wrong Answer even if one of the given answers happens to be correct and there will be same penalty as above to that question.
- c) If a question is left blank, i.e no answer is given by the candidate, there will be no penalty for that question.
- Part-II: Questions of Part-II of Paper-II are to be answered either only in English or in Bengali. The medium once chosen should be uniformly followed all through the test. It must not be partly in English and partly in Bengali. Answers are to be scratched in case of violation of this instruction.

Provisional Answer Key of Section-II of the Paper-I and Part-I of Paper-II will be uploaded on the website of TPSC on completion of the Preliminary Examination for which candidates may submit representations if any within 7 (seven) days from the date of uploading of Provisional Answer Key.

Mobile Phone/Electronic Gadgets etc. are banned in the Campus of the Examination Hall. Any Phone/ Electronic Gadget found in possession of any candidate in the Examination Hall shall be confiscated forthwith and he/she may be debarred from appearing at the Examination and also for the Examination(s) to be conducted by the Commission in future.
